However, dues payments may be deductible as ordinary and necessary business expenses, subject to an exclusion for lobbying activity. Because a portion of your dues is used for lobbying by NAHB, FHBA and the HBA of Panama City - Bay County, \$78.95 is not deductible for income tax purposes. \$1.00 of your dues goes to Political Action Committee and is not tax deductible. If you do not wish to contribute to the PAC you can note this when you give payment for your dues and/or renewal dues. You agree that this money will then go to the general fund instead.
